

# 'Gridiron 100' – Terms and Conditions – 2019

**This event is run under CTC rules.**

The Gridiron is NOT a race or trial of speed. You are expected to follow the rules of the road and show consideration to other road users. The route is on open public and forest roads. You should prepare by studying the route - the route is not waymarked or marshalled. You are solely responsible for your safety/conduct. The organiser provides no rescue service. The CTC provides these routes on a voluntary basis. The provision of the routes does not imply a guarantee of safety and the riders must consider themselves on a private excursion and ensure that their cycles are in roadworthy condition and that they have the experience and level of fitness to complete the ride. **Tri-bars are not permitted** as they do not allow the degree of control necessary to safely ride in a group.

**Disclaimer:** I agree that I understand and will abide by the terms and conditions required by the CTC for the safe participation in this activity, to act responsibly and obey the rules of the Highway Code, the Countryside Code and the New Forest Cycling Code [http://www.newforestnpa.gov.uk/info/20045/things\\_to\\_do/36/cycling/3](http://www.newforestnpa.gov.uk/info/20045/things_to_do/36/cycling/3). ## **Parental Consent for CTC cycling activities**

**All participants under 18 years must be entered by their parent/guardian and be accompanied by a responsible adult cycling with them in loco parentis.**

The 'Gridiron 100' does not accept entries from unaccompanied cyclists under 18 years old. There is no lower limit if accompanied by a responsible adult acting in loco parentis. Children are welcome but parents/guardians must understand while the CTC extends a welcome to cyclists of all ages and abilities there is no special provision made for children on this activity.

Parents/Guardians must be aware of the demands of any activity, and that they alone make the decision about the ability of the child to complete the activity. Arrangements to get to and from the ride are wholly their responsibility.
